Our Privacy Policy

Jazz Radio Network Privacy Policy

Media Arts Institute LLC, a Washington State entity (us", "we", or "our") operates <https://www.jazzradionetwork.com> (the "Site"). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

Information Collection And Use

Log Data

Refund & Return Policy

Jazz Radio Network Refund & Return Policy

Thanks for shopping at the Jazz Store located at Jazz Radio Network.com

If you are not entirely satisfied with your purchase, we're here to help. Refunds and returns are not accepted unless the item is damaged or defective, or not what you ordered.

Returns

Any claims for misprinted/damaged/defective items must be submitted within 30 days after the product is received. For packages lost in transit, all claims must be submitted no more than 30 days after the estimated delivery date.

Returns are accepted and refunds given only if you received the wrong product ordered or there is a defect or error in the manufacturing of the product. Be aware that we may require a **photo** to be submitted with your problem email inquiry to begin a reshipment. It is always best to include photos with your initial problem report to avoid delays.
